

# OnePath and OptiMix Diversified Funds: Review and Adjustment of Strategic Asset Allocation

PRODUCT UPATE AND CONTINUOUS DISCLOSURE NOTICE | 24 MAY 2021

This Product Update and Continuous Disclosure Notice provides important information for current investors in ANZ OneAnswer Investment Portfolio (including //Select), OneAnswer Frontier Investment Portfolio, ANZ OneAnswer Personal Super and Pension (including //Select) and OneAnswer Frontier Personal Super and Pension.

#### What are the changes?

Following a recent review of the OptiMix and OnePath diversified funds' strategic asset allocation, the funds' strategic asset allocation benchmarks and associated ranges will be adjusted, effective 24 May 2021. The changes include the addition of a new asset class 'unlisted assets' as outlined in the tables on the following pages.

'Unlisted assets' is a generic term referring to investments that are not listed on any tradeable exchange such as a stock market. They can include such investments as property, infrastructure, private equity or hedge funds.

The role of 'unlisted assets' in the OptiMix and OnePath diversified funds is to contribute an attractive return and risk trade-off that is lowly correlated to the funds' other asset classes. Unlisted assets exposure in the OptiMix and OnePath diversified funds will initially comprise investments in unlisted property and may include other suitable investments that fit this profile in future.

The following funds, referred to collectively as 'the Funds', will be affected:

- OnePath Balanced
- OnePath Active Growth
- OnePath Managed Growth
- OnePath High Growth
- OptiMix Conservative
- OptiMix Moderate

- OptiMix Growth
- OptiMix High Growth.
